In accordance with Alberta Elections laws, <https://www.elections.ab.ca/political-participants/>, the method that we have chosen is to collect Albertan voting citizens' signatures. The best reference to see if you qualify as a voter may be found at this official site, <https://www.elections.ab.ca/voters/who-can-vote/>.

The form has to be completed by the old-fashioned physical, manual 'handraulic' method. No digital signatures are permitted by the provincial Chief Electoral Officer. We need 8,473 elector signatories for the petition. If you, your family, your neighbours and friends are interested in being a signatory, please fill out this pdf form and mail it.

Print the table using landscape orientation and 8.5 x 14.

Filling Out the Registration Petition

Elections Alberta requires that each person, in each row, signing registration petition must print very neatly, clearly and include the full information on the table as it is. If anything in the row cannot be read by Elections Alberta Chief Electoral Officer., then that whole row is not counted. The full residential address, including city and postal code must be written clearly. Only residential addresses will be accepted.
